1. What is this product about?

- I-Linked Accelerating DD Rider 2 unit deducting critical illness rider that accelerates the benefit under the basic policy. It has to be attached to a regular premium investment-linked basic policy offered by MCIS Insurance Berhad (MCIS Life). The benefits are provided below.
- This rider provides coverage up to 90 years old or end of the basic policy term, whichever is earlier.

2. What are the covers / benefits provided?

Rider Sum Assured = RM 6,000 Rider Term = 79 years

This rider covers the following:

Upon Life Assured diagnosed to undergo Angioplasty and Other Invasive Treatments for Major Coronary Artery Disease.	RM 600 (10% of the Rider Sum Assured, subject to a maximum of RM 25,000) shall be payable and both the Rider Sum Assured and Basic Sum Assured shall be reduced accordingly.
Upon diagnosis of any of the 36 Critical Illnesses of Life Assured prior to age 90.	Rider Sum Assured (RM 6,000) minus any claim paid under Angioplasty and Other Invasive Treatments for Major Coronary Artery Disease becomes payable and the Basic Sum Assured shall be reduced by 100% of the rider claim amount. This rider is terminated thereafter.

3. How much insurance charge do I have to pay?

- The insurance charges vary depending on the coverage chosen, attained age, gender etc. Please refer to the Product Illustration for the exact details.
 - The insurance charges duration is 79 years.
- The Insurance Charges illustrated in the Product Illustration are applicable to standard risks. The rider terms and rates may vary depending on the underwriting requirements.
- Insurance charges are to be determined based on your age next birthday at the policy anniversary.
- Insurance charges are not level and are not guaranteed. The Company reserves the right to adjust the insurance charges by giving 30 days' prior notice. Claims experience, cost of medical treatment and medical inflation are some of the factors which may to the adjustment of the insurance charges. Changes in insurance charges will only be made on policy anniversary.

4. What are the fees and charges that I have to pay?

The insurance charges are deducted monthly from your account value for the coverage provided. The insurance charges will increase as you grow older. Details of the insurance charges for this rider are provided in the Product Illustration.

5. What are some of the key terms and conditions that I should be aware of?

- Importance of disclosure – you must disclose all material facts such as medical condition, occupation and state your age correctly.
- Free-look period – you may cancel your rider by returning the supplementary contract within 15 days after you have received the supplementary contract. The insurance charges which have been deducted (less any medical fee incurred) will be refunded to you.
- Waiting period - the eligibility for benefits under the rider will only start 30 days after the inception of the rider .
- Policy Lapse – the rider will lapse when the value of the investment units is insufficient to pay for the insurance and other charges,

6. What are the major exclusions under this rider?

The rider benefit shall not be payable if the insured events cause directly or indirectly, wholly or partly, by any of the following occurrences:

- (a) Pre-existing illness.
- (b) Critical Illness first manifests during the waiting period.
- (c) Coronary Bypass Surgery if the Life Assured is diagnosed as having suffered a Myocardial Infarction (heart attack) prior to the Issue Date or any reinstatement date of the rider.
- (d) Myocardial Infarction (heart attack) if the Life Assured had undergone Coronary Bypass Surgery prior to the Issue Date or any reinstatement date of the rider.
- (e) Injury or illness caused by self-inflicted injury or duelling while sane or insane.
- (f) Injury or illness suffered during active participation in riot, strike or civil commotion, committing an unlawful act, by the hands of justice, wilful misuse of alcohol, taking of drugs not prescribed by a registered medical practitioner.
- (g) Injury or illness suffered either directly or indirectly from insurrection, war or invasion or any act incidental thereto (whether declared or not) or from aviation (except as an ordinary fare-paying passenger or crew member on a regular public air service) or gliding, motor racing, horse racing or submarine operations.

7. Can I cancel my rider?

You may cancel your rider by giving a written notice to the Company.

8. What do I need to do if there are changes to my contact details?
