EXECUTIVE SUMMARY

Malaysian equity market posted a positive gain in the month of December 2025 with the FBMKLCI Index closed at 1,680.11 points (4.7% MoM and 2.3% YTD). The performance was lagging behind regional peers, which recorded double digit growth on a year to date basis. This was due to the continuous foreign selling of local equities market throughout the year. The average daily trading value on Bursa Malaysia fell more than 20% for YoY in 2025 to RM3.1bil (RM4.bil in 2024). Meanwhile, the average daily trading volume on Bursa Malaysia fell 19.2% YoY to 2.5bil units (3.12bil units in 2024).

Malaysia Government Securities (“MGS”) yields were largely unchanged in the month, given the slow holiday season. Brent crude oil prices declined to USD60.85/barrel as at end-Dec'25 (end-Nov'25: USD63.20/barrel). Meanwhile, ringgit continued to strengthen sharply against dollar to RM4.060/USD in Dec'25 (Nov'25: RM4.133/USD).

On the local economic data, inflation rose slightly to +1.4% YoY in Nov'25 (Oct'25: +1.3% YoY), attributed to higher alcoholic beverages & tobacco prices (Nov'25: +2.4% YoY; Oct'25: +0.3% YoY) as well as education prices (Nov'25: +2.6% YoY; Oct'25: +2.4% YoY).

Moving forward, we continue to remain positive on Malaysia's equity market in 2026, supported by strong domestic fundamentals, improving company earnings, and lower external risks, which could lead to higher market valuations. The strengthening in ringgit will also support the domestic market recovery after a volatility recorded in 2025.

For fixed income, in Malaysia, BNM is anticipated to maintain the monetary policy in 1H2026, given the better-than-expected GDP growth and moderate inflation data. The external risk factors such as global trade disruption, Middle East conflict and Russia-Ukraine geopolitical tension will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, our fixed income strategy will remain defensive to shelter from the market volatilities in the near term.

Based on the table below, on monthly basis, MCIS Life Income Fund and MCIS Life Jati Fund had outperformed their benchmarks.

Policyholders are encouraged to focus on regular premiums given the current risk and volatile period of the economic and market condition. Risk-averse investors should focus on income funds due to its less volatile as compared to equity-related funds.





Investment Objective

To achieve steady stream of income and capital appreciation over the long-term (5 to 10 years of period) by investing in Principal Islamic Asia Pacific Dynamic Equity Fund ("PIAPDE").

Investment Strategy

This is a feeder fund structure that invests primarily in the PIAPDE. PIAPDE aims to achieve long-term capital appreciation and income while complying with Shariah investment criteria, through investments in the emerging and developed markets of Asia Pacific ex Japan region. PIAPDE's asset can be invested in Shariah-compliant equities, Shariah-compliant warrants, Islamic options, participation in Islamic Collective Investment Scheme which are permitted by Securities Commission Malaysia as well as Sukuk and Islamic Deposits. Besides PIAPDE, the Fund would also invest in Islamic money market instruments.



MCIS Life Global Yakin Fund

Monthly Report (December 2025)

Investment Objective

To achieve capital appreciation over the long-term (5 to 10 years of period) by investing in abrdn Islamic World Equity Fund ("AIWEF"). However, the Fund is not a Shariah-compliant product.

Investment Strategy

This is a feeder fund structure that invests primarily in AIWEF (formerly known as Aberdeen Standard Islamic World Equity Fund). 





Equity Market Review and Outlook

Market Review

The Malaysian equity market posted a positive gain in the month of December with the FBMKLCI Index closed at 1,680.11 points (4.7% MoM and 2.3% YTD). The performance was lagging behind regional peers, which recorded double digit growth in a year to date basis. This was due to the continuous foreign selling of local equities market throughout the year. The average daily trading value on Bursa Malaysia fell more than 20% for YoY in 2025 to RM3.1bil (RM4.1bil in 2024). Meanwhile, the average daily trading volume on Bursa Malaysia fell 19.2% YoY to 2.5bil units (3.12bil units in 2024).

Local institutions stayed net buyers of Malaysian equities for the seventh consecutive month, with net buy flows of RM2.5bil in December 2025 (RM21.9bil in 2025). On the other hand, local retail investors stayed net sellers for the fourth consecutive month at RM411mil (RM227mil of net buy in 2025). Foreign investors continued as net sellers of Malaysian equities in the month, with net sell flows of RM2.0bil (RM22.1bil in 2025).

Global equities ended the month of December with mixed but generally positive performance. In the U.S., the S&P 500 Index softened by 0.1% MoM, bringing its YTD return to 16.4% and the Dow Jones Industrial Average Index modestly gained by 0.7% MoM (+13.0% YTD). The European equities market posted mixed performances with steady gain in December. The MSCI Europe Index registered a gain of 2.6% MoM. The Asia-Pacific ex-Japan regions were mostly posted positive performances. The strong performance in the region was reflecting a renewed optimism around China-linked equities and policy support expectations. The MSCI Asia APEX 50 ex-Japan closed higher by 4.4% MoM.

Market Outlook & Strategy

Traditionally, FBMKLCI Index's performance was mixed in January, with an average of 0.8% and -0.9% for both MoM returns over the past 10 years and 45 years. We expect the market to be supported by its attractive valuations at current levels of 15.9x PER, as it is now below its 15-year historical average of 16.8x and P/B of 1.58x, below the 15-year historical average of 1.83x.

The FBMKLCI maintained its bullish reversal after breaking above the downtrend line from its August 24 peak, with the index trading above most of its moving average lines. It showed resilience after being sideways in July. The MACD remained in bullish territory throughout the month, and the RSI is strongly touching the overbought levels. As the sentiment is shifting in favour of the bulls, we anticipate the index to range between 1,525 points (200-day SMA) as key support and resistance at 1,695 points (5-year high).

We continue to be positive on Malaysia's equity market in 2026, supported by strong domestic fundamentals, improving company earnings, and lower external risks, which could lead to higher market valuations. The strengthening in ringgit will also support the domestic market recovery after a volatility recorded in 2025.

Fixed Income Review and Outlook

Market Review

Malaysia Government Securities ("MGS") yields were largely unchanged in the month, given the slow holiday season. Brent crude oil prices declined to USD60.85/barrel as at end-Dec'25 (end-Nov'25: USD63.20/barrel). Meanwhile, ringgit continued to strengthen sharply against dollar to RM4.060/USD in Dec'25 (Nov'25: RM4.133/USD).

On the local economic data, inflation rose slightly to +1.4% YoY in Nov'25 (Oct'25: +1.3% YoY), attributed to higher alcoholic beverages & tobacco prices (Nov'25: +2.4% YoY; Oct'25: +0.3% YoY) as well as education prices (Nov'25: +2.6% YoY; Oct'25: +2.4% YoY).

Malaysia exports growth slowed to +7.0% YoY in Nov'25 (Oct'25: +15.7% YoY), weighted down by lower manufacturing exports and contraction in agriculture exports. Besides, exports to ASEAN market also grow slower at +5.9% YoY (Oct'25: +20.1%) while exports to US market declined to -0.9% YoY (Oct'25: -2.6% YoY). Meantime, Malaysia imports expanded by +15.8% YoY in Nov'25 (Oct'25: +10.0% YoY), reflecting the sharp increment in capital goods imports and rebound in intermediate goods imports. All in all, the trade surplus narrowed to +RM6.1bil in Nov'25 (Oct'25: +RM20.4bil).


BNM international reserves improved further to USD125.5bil as at end-Dec'25 (end-Nov'25: USD124.1bil). The reserves position is sufficient to finance 4.7 months of imports of goods and services and is 0.9 times of the total short-term external debt.



US 10-year Treasury yield jumped strongly to 4.17% as at end-Dec'25 (end-Nov'25: 4.02%) despite of its 25bps Fed rate cut in the month, making its third in a row. The market is now expecting slower rate cut in 2026 after mixed economic data fueled different views on the outlook.

Market Outlook & Strategy

In Malaysia, BNM is anticipated to maintain the monetary policy in 1H2026, given the better-than-expected GDP growth and moderate inflation data. The external risk factors such as global trade disruption, Middle East conflict and Russia-Ukraine geopolitical tension will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, our fixed income strategy will remain defensive to shelter from the market volatilities in the near term.
