This Product Disclosure Sheet (PDS) provides you with key information on your medical and health insurance.

Other customers have read this PDS and found it helpful; **you should read it too.****1 What is CI Multi Shield (With Cancer Recovery Benefit)?**

CI Multi Shield (With Cancer Recovery Benefit) is a non-participating unit deducting rider which provides coverage upon diagnosis of any one of the 126 covered critical illnesses events at early, intermediate, and advanced stages. This rider provides additional coverage for Angioplasty and Other Invasive Treatments for Coronary Artery Disease and Diabetic Complications. This rider also provides optional Cancer Recovery Benefit.

2 Know Your Coverage/Benefits**As an illustration, you will receive the following coverage:***This is applicable for a non-smoker male aged 30 next birthday, with rider term of 50 years, Sum Assured of RM100,000 and standard risk.*

Staged Critical Illness Benefit	RM100,000 for advanced stage critical illness; or RM60,000 for intermediate stage critical illness; or RM30,000 for early stage critical illness. The maximum total amount payable is RM100,000 .
Special Critical Illness Benefit	Angioplasty and Other Invasive Treatments for Coronary Artery Disease: RM10,000 Diabetic Complications: RM10,000
Cancer Recovery Benefit	RM100,000 for advanced stage cancer; or RM60,000 for intermediate stage cancer; or RM30,000 for early stage cancer. The maximum total amount payable is RM100,000 .
Additional Coverage	Not applicable.

2. Stroke

3 Know Your Obligations

4 Other Key Terms

- You must disclose all material facts such as medical condition and state your age correctly. Otherwise, you may risk having your claim rejected or rider terminated.
- The rider terms and Insurance Charges may vary depending on the underwriting requirements of MCIS Insurance Berhad.
- Insurance Charges are not guaranteed. MCIS Insurance Berhad reserves the right to revise the Insurance Charges by giving 30 days' prior written notice.
- Your coverage will only start if there are no signs or symptoms leading to the diagnosis of your condition during the applicable waiting period. For Special Critical Illness Benefit and critical illness events under early and intermediate stage, the waiting period is 60 days from the effective date of insurance. For critical illness events under advanced stage, the waiting period is 30 days from the effective date of insurance except for Cancer, Coronary Artery By-Pass Surgery, Heart Attack and Serious Coronary Artery Disease, where the waiting period is 60 days.
- The rider will lapse when the Account Value is insufficient to pay for the Insurance Charges.
- You can obtain information on claim procedures and relevant forms by contacting MCIS Insurance Berhad.
- If you switch your policy from one insurer to another or transfer from one type of insurance plan to another, you may be subject to new terms and conditions of the new insurance plan or of the new insurer.

? Can I cancel my rider?

Yes, you may cancel your rider by giving a written notice to MCIS Insurance Berhad.

- **Free Look Period:** You may cancel your rider within 15 days from the date of delivery of the Policy. The Insurance Charges which have been deducted less any medical expenses incurred will be refunded to the Account Value.
- **After Free Look Period:** If you decide not to continue this rider after the free look period, you can cancel by writing to MCIS Insurance Berhad.
