

### Can I cancel my rider?

- Free Look Period: You may cancel your rider only if you cancel EduSecure within 15 days from the date of delivery of the Policy. MCIS Insurance Berhad will refund to you the premium paid less any medical expenses incurred without interest.
- After Free Look Period: If you decide not to continue this rider after the free look period, you can cancel only if you surrender EduSecure by writing to MCIS Insurance Berhad.
